Question No. 3:

Žádáme o ujasnění počtu dodaných vzorků na batch a počtu batchů pro jednotlivé typy služeb uvedené v zadávací dokumentaci 01_TS_SEQ24_v2.xlsx v buňkách B6-B10.

Answer No. 3:

Počty nejsou předem známe.

Question No. 4:

Prosíme o specifikaci, o jaký typ analýzy se jedná ve službách uvedených v zadávací dokumentaci 01_TS_SEQ24_v2.xlsx v buňkách B6-B9. Potřebujeme vědět, zda se jedná o celogenomovou analýzu nebo pouze mezidruhové srovnání.

Question No. 5:

Žádáme o informaci, zda je pro všechny servisy uvedené v tabulce 01_TS_SEQ24_v2.xlsx v buňkách B6-B9 vyžadován totožný kit na přípravu NGS knihoven.

Question No. 1:

We request information whether in the tender documentation 01_TS_SEQ24_v2.xlsx in cell B7 the Illumina MiSeq or NextSeq 1000/2000 systems are considered to meet the requirements for a comparable sequencing platform to NovaSeq6000.

Answer No. 1:

Question No. 2:

In the tender document 01_TS_SEQ24_v2.xlsx in cell B8 we ask for clarification if this is only for resequencing without library preparation.

Answer No. 2:

Including library preparation.

Question No. 3:

We request clarification on the number of samples delivered per batch and the number of batches for each type of service listed in the tender document 01_TS_SEQ24_v2.xlsx in cells B6-B10.

Answer No. 3:

The numbers are not known in advance.

Question No. 4:

Please specify what type of analysis is involved in the services listed in the tender document 01_TS_SEQ24_v2.xlsx in cells B6-B9. We need to know if this is a whole genome analysis or just an interspecies comparison.

Answer No. 4:

Whole genome analysis.

Question No. 5:

We request information on whether an identical NGS library preparation kit is required for all services listed in Table 01_TS_SEQ24_v2.xlsx in B6-B9 cells.

Answer No. 5:

The library preparation kit is not specified.
