#### REQUEST FOR CLARIFICATION OF THE TENDER DOCUMENTATION

On 19.12.2024, the contracting authority received the following questions in the context of the supplier's request for explanation of the tender conditions:

#### Question 1:

We have checked the tender content and we are in general a technically suitable solution provider but lead time of 30 weeks restricts us to fulfill the requirement. We kindly ask you to check if a lead time can be extended to 40 ... 42 weeks after contract signing.

#### Answer from the contracting authority:

The Contracting Authority amends Clause IV.2 of the draft Purchase Contract as follows:

#### Deadline for submission of the Item

The Seller undertakes to hand over the Item within 40 weeks from the effective date of the Contract. The Seller's failure to deliver the Item shall be deemed a material breach of the Contract.

## Question 2:

We would like to know when comments of both sides will be proceed in respect to the purchase contract draft.

### Answer from the contracting authority:

In case of any queries or ambiguity relating to the provisions of the Purchase Contract, the contracting authority recommends sending a message in the form of a Request for Explanation of the Tender Documents through E-ZAK. After the deadline for submission of tenders has passed, the tender conditions, including the draft purchase contract, may no longer be amended and the purchase contract, which forms part of the tender conditions, will be signed with the selected supplier. If a contract is concluded that does not comply with the tender conditions, this would be a violation of Act No. 134/2016 Coll., on public procurement, as amended.

### 2. CHANGE IN THE TENDER DOCUMENTATION

In view of the modifications to the purchase contract, the contracting authority attaches to this explanation of the tender documentation the modified annexes marked:

- modified purchase contract in ČJ:

- modified purchase contract in AJ:

Suppliers are required to comply with the above modified Annexes and to complete and submit a modified Purchase Contract in the tender.

#### 3. DEADLINE FOR SUBMISSION OF TENDERS

The contracting authority, in accordance with Section 99(2) of the Public Procurement Act, has decided, in view of the nature of the responses to the requests for clarification of the tender documentation received and the modifications to the purchase contract, to extend the deadline for submission of tenders so that it is at least its full original length from the time of sending this explanation.

The contracting authority has therefore extended the deadline for the submission of tenders <u>until 10:00 on 4 February 2025</u>.
