1) Subject of the contract

The subject of this contract is the supply of the **institutional media management software (media library)**; permanent SW licence and 5-year SW maintenance and support is required.

The bids for a particular software type should follow the detailed technical specifications listed in the in the Annex 1 – Business Terms and Conditions.

- 4) Estimated value of the contract: 560 000 CZK (excl. VAT).

5) Submission of tenders:

6) Formal requirements on the tenders

Tenders must be elaborated in Czech and English language in form of draft contract (5 copies) signed by a person authorised to do so by the supplier. Detailed technical specification of the offered SW shall be attached to each draft contracts as annex 1.

Bids submitted in printed form

Tenders must be enclosed in the envelope with both, the address of the purchaser and the supplier indicated, and must be marked as follows: "*NEOTVIRAT! Verejna zakazka – Institutional Media Management Software (Media Library)*".

Bids submitted in electronic form

7) Opening of Envelopes

The tenderers whose tenders have been delivered to the contracting authority within the time limit for the submission of tenders are entitled to take part in the opening of envelopes. The purchaser is entitled to require of the tenderers present to confirm their participation in the opening of envelopes by signing the attendance list of the tenderers being present. 8) Requirements on price

The purchase price must include all the unavoidable costs on deliveries and services that are necessary for proper and timely completion of the subject of the contract including any related costs.

9) Contract award criterion

The tender shall be awarded on base of the lowest price.
